Council Tax Support Headline Rate Comparison









The following tables illustrate the impact of changing the headline Council Tax Support discount rate will have on the residents of each District and Borough Council.

Each table:

- Gives an indication of how many existing Council Tax Support claimants will be affected per property band.
- Shows the average Council Tax charge per Band for two scenarios, the first for more than one adult in the property therefore a starting point of 100% liability (full charge) and the second based on a single occupier receiving a non means tested 25% Single Resident Discount therefore a starting point of 75% liability.
- Compares the minimum amount payable per week based on the existing Council Tax Support discount rate for each District and Borough against the minimum amount payable per week based on the proposed Council Tax discount rate for North Northamptonshire Council.
- Gives an indication of how much a Council Tax Support claimant's minimum contribution towards their Council Tax is likely to change by.

The information provided is based on June 2020 claimant caseload figures and 2020/21 Council Tax charges.
