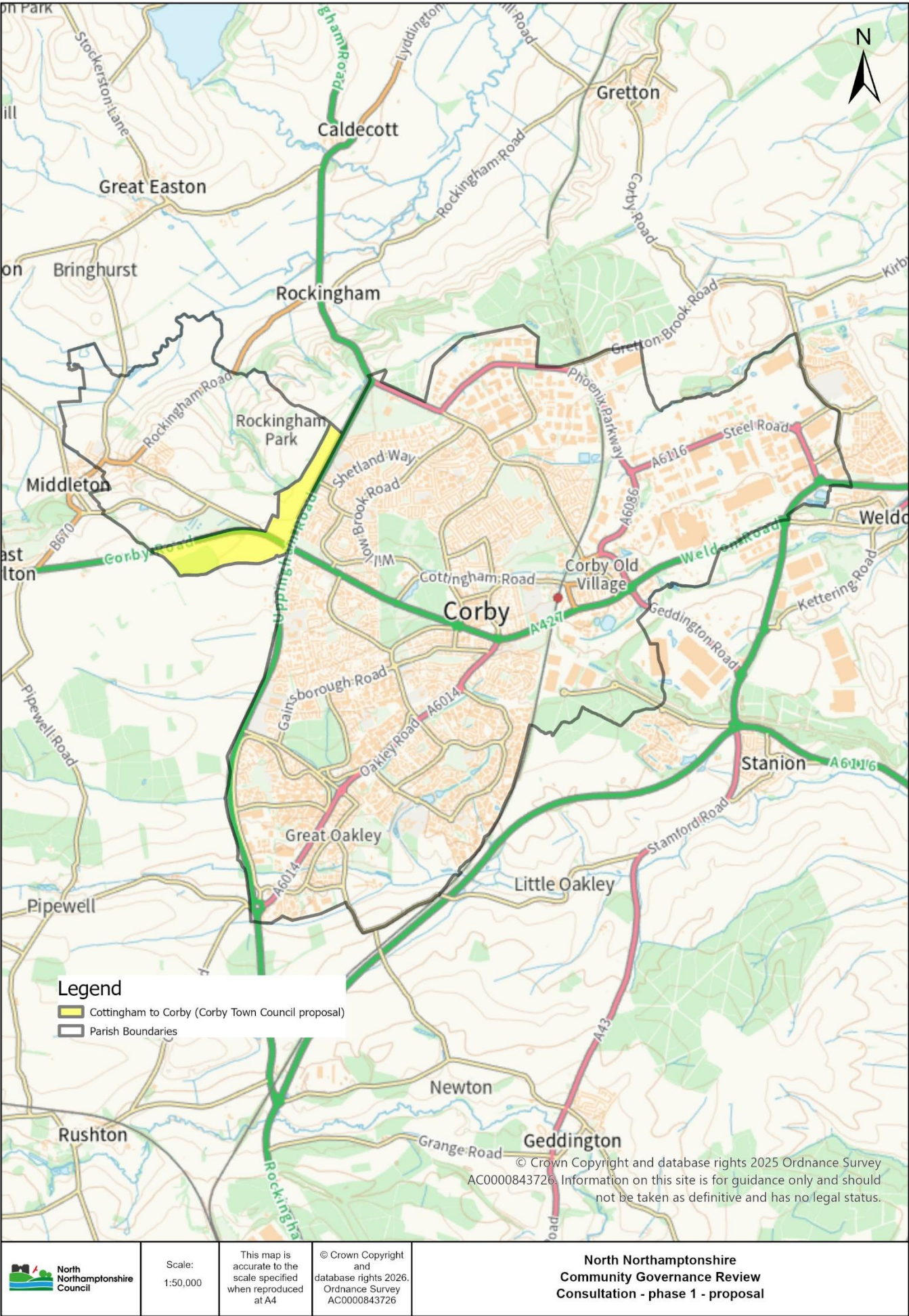
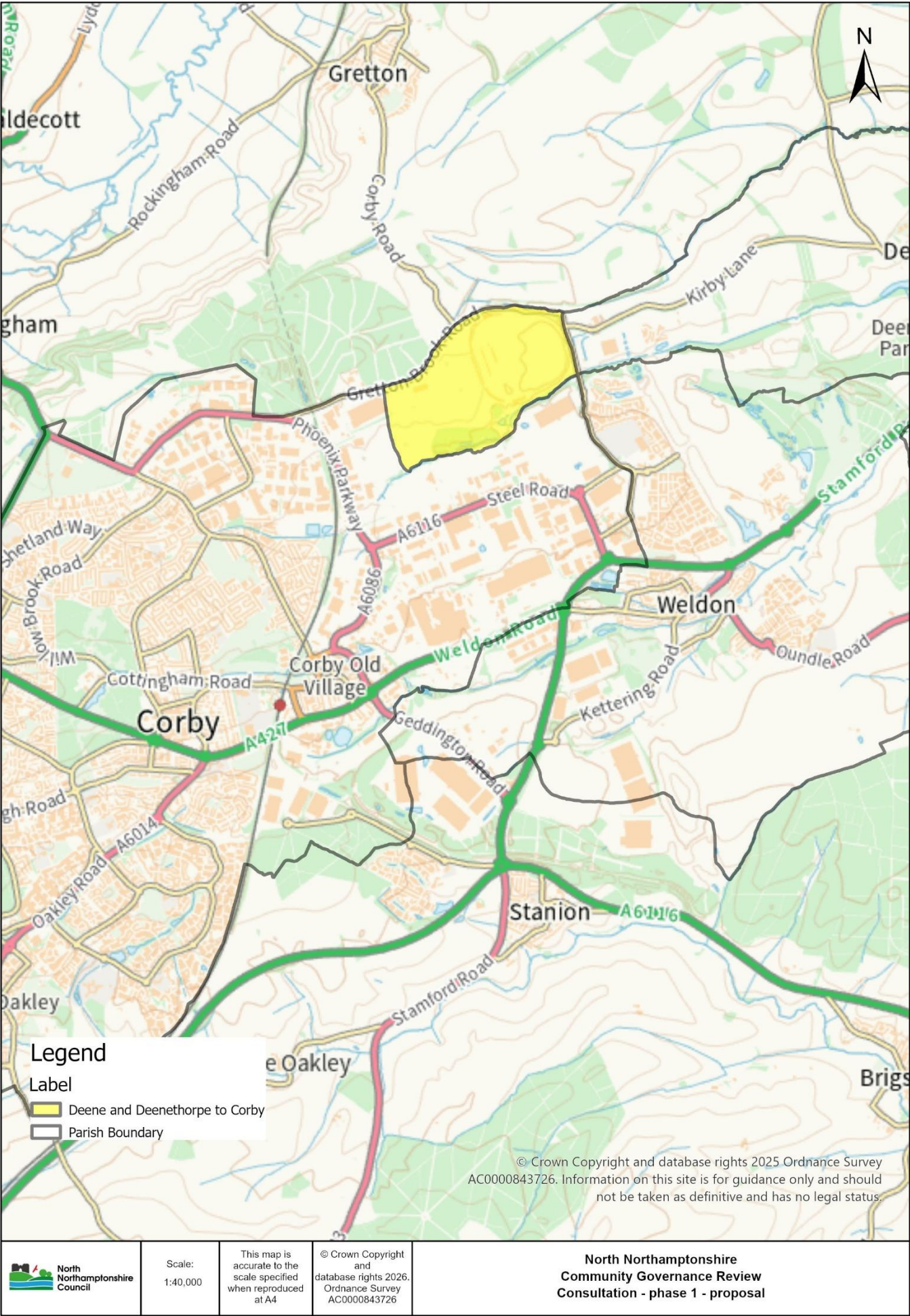


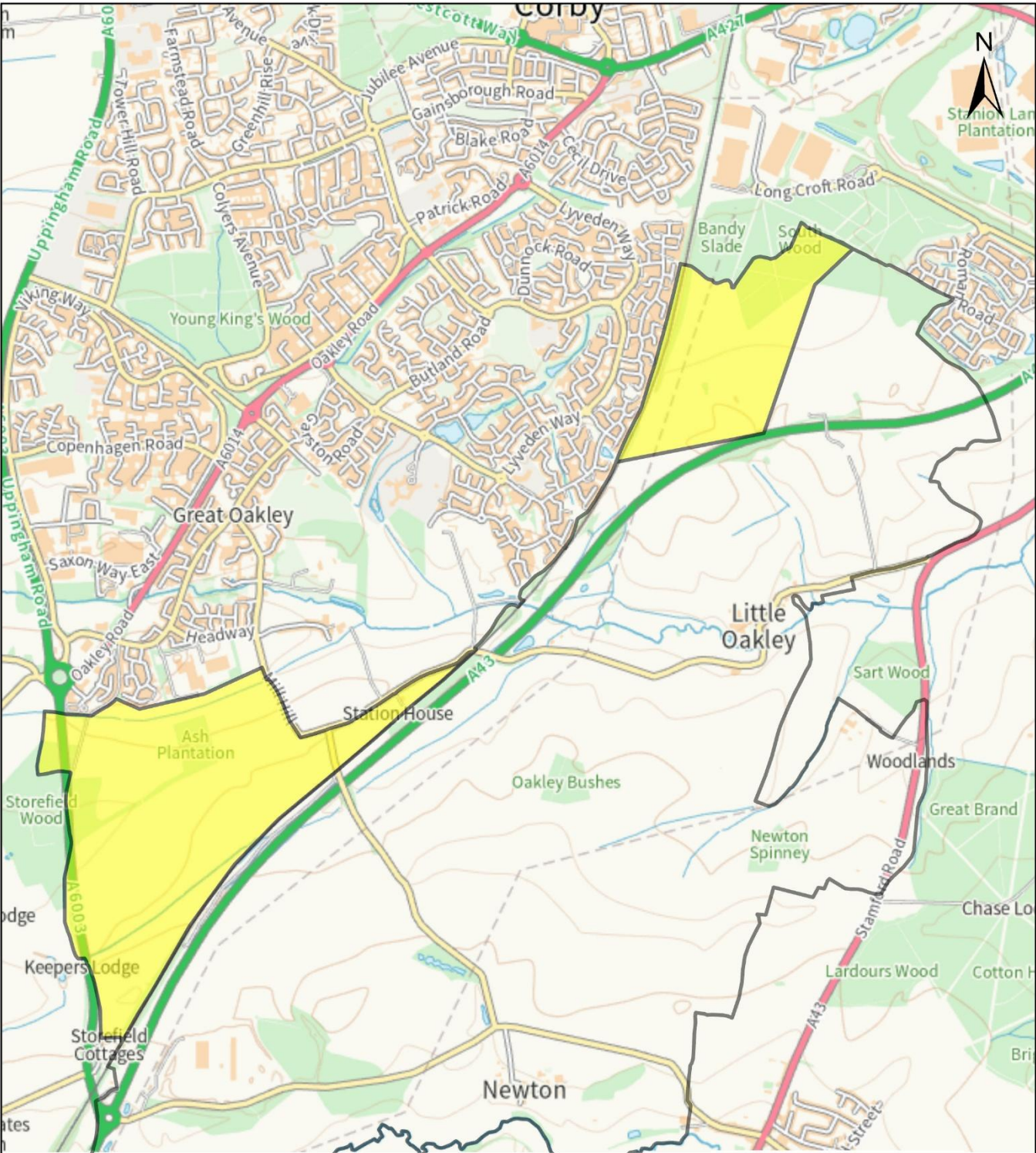
DRAFT RECOMMENDATION 2a CORBY_COTTINGHAM – a proposal suggested moving the area shaded yellow into the parish of Corby.

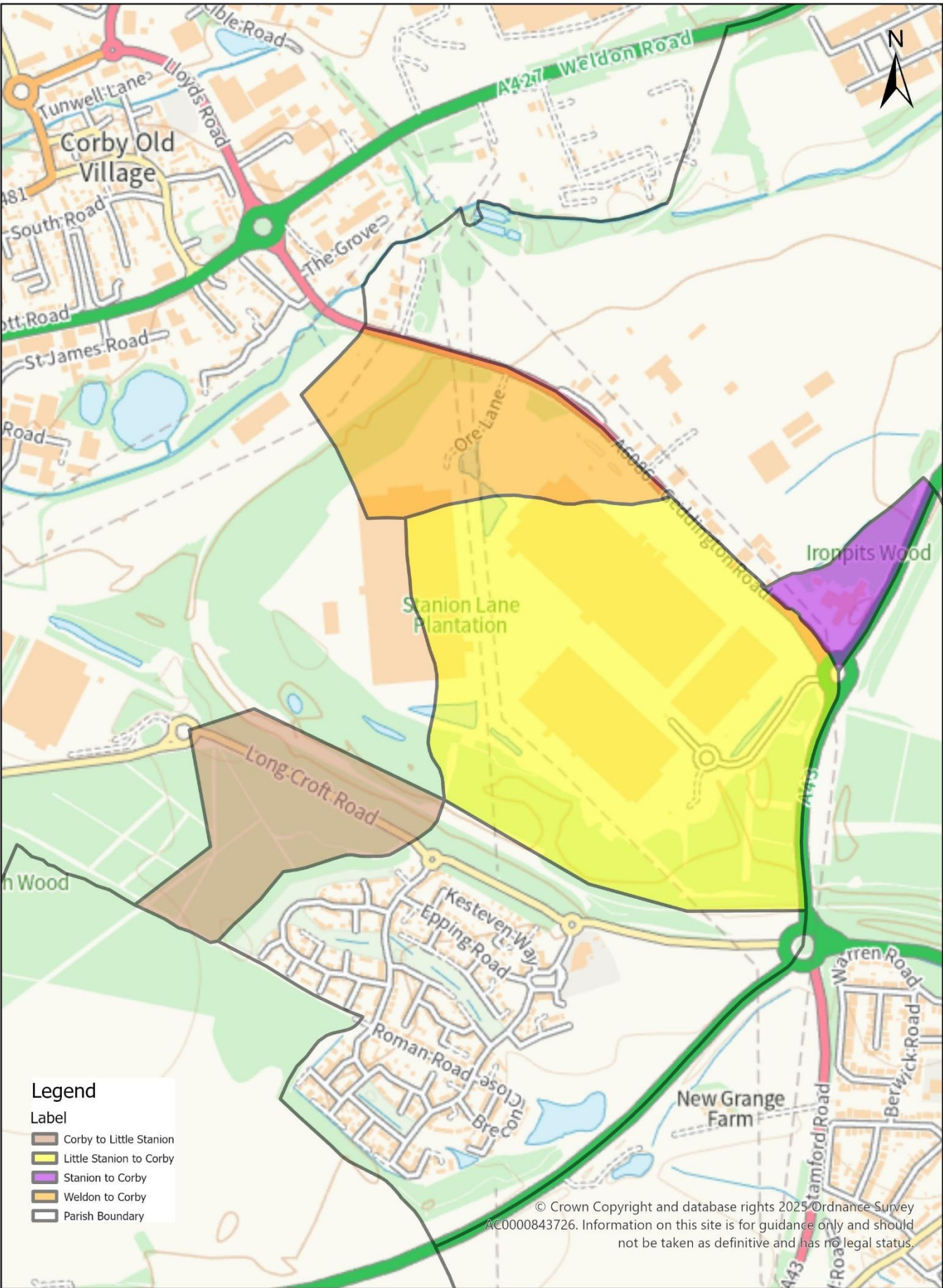

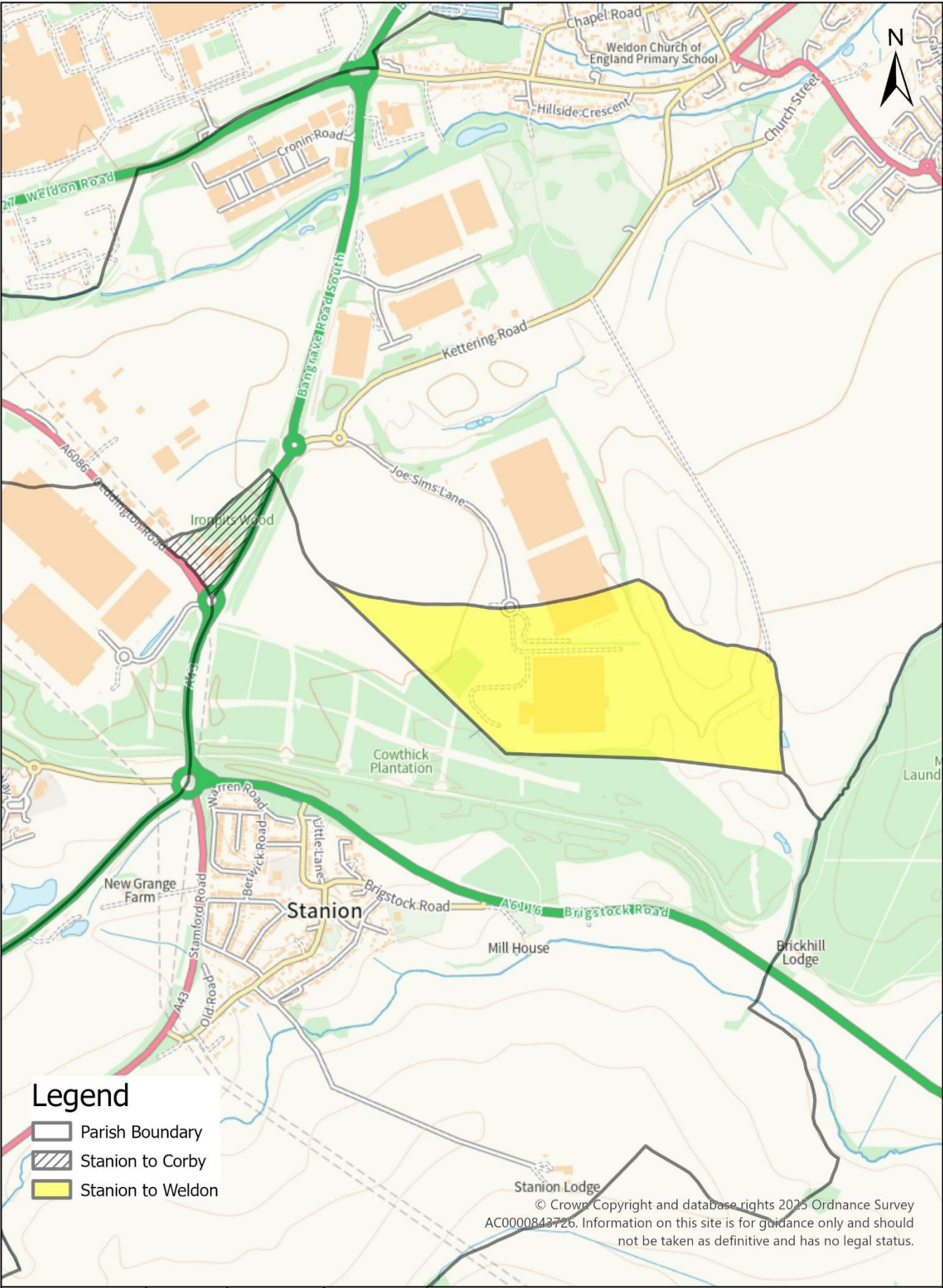

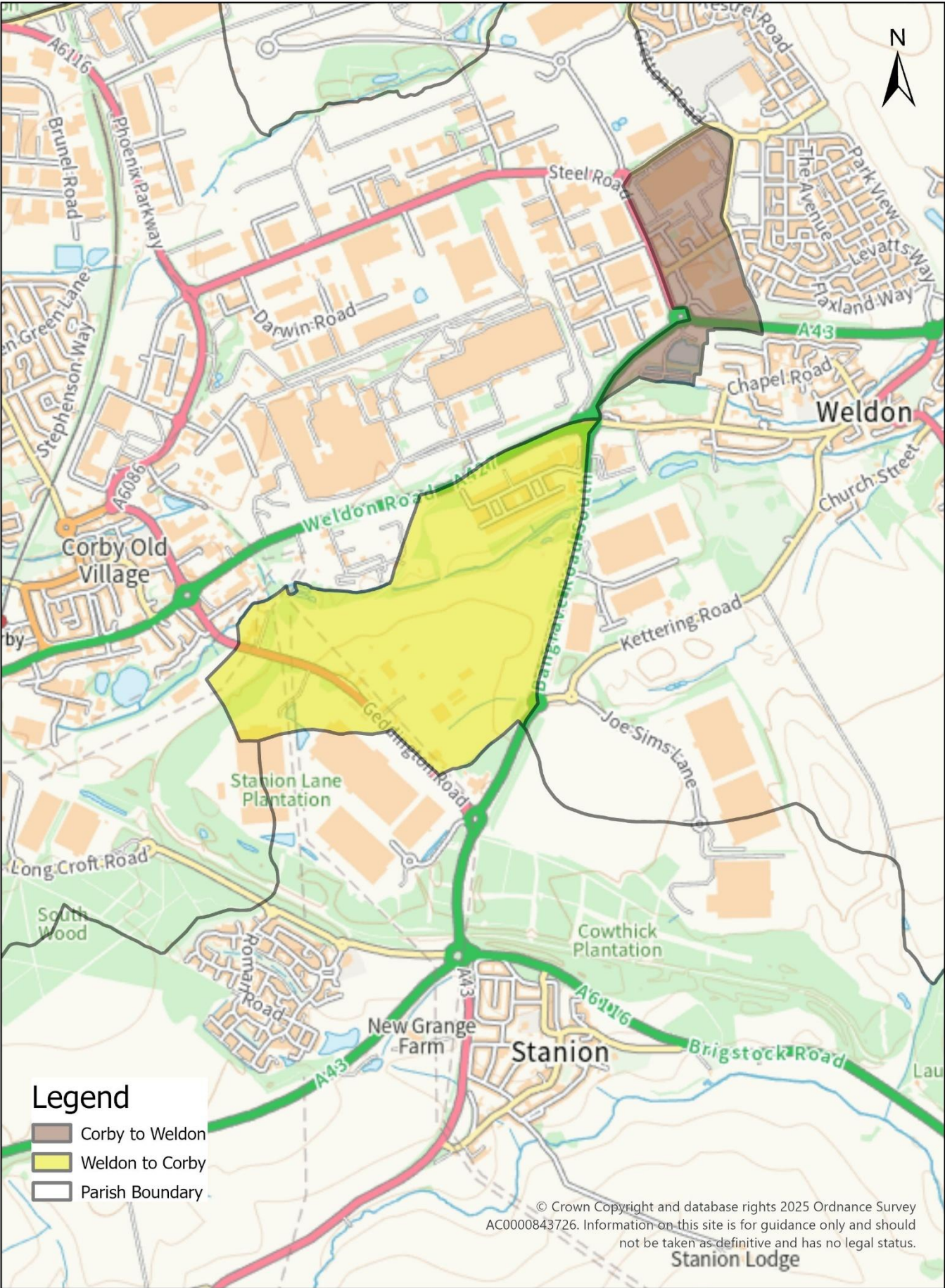
DRAFT RECOMMENDATION 2d CORBY_LITTLE STANION – a proposal suggested moving the area shaded brown from Corby into the parish of Little Stanion. Suggested new boundary along A6086 with areas shaded in yellow, orange and purple transferred to Corby.



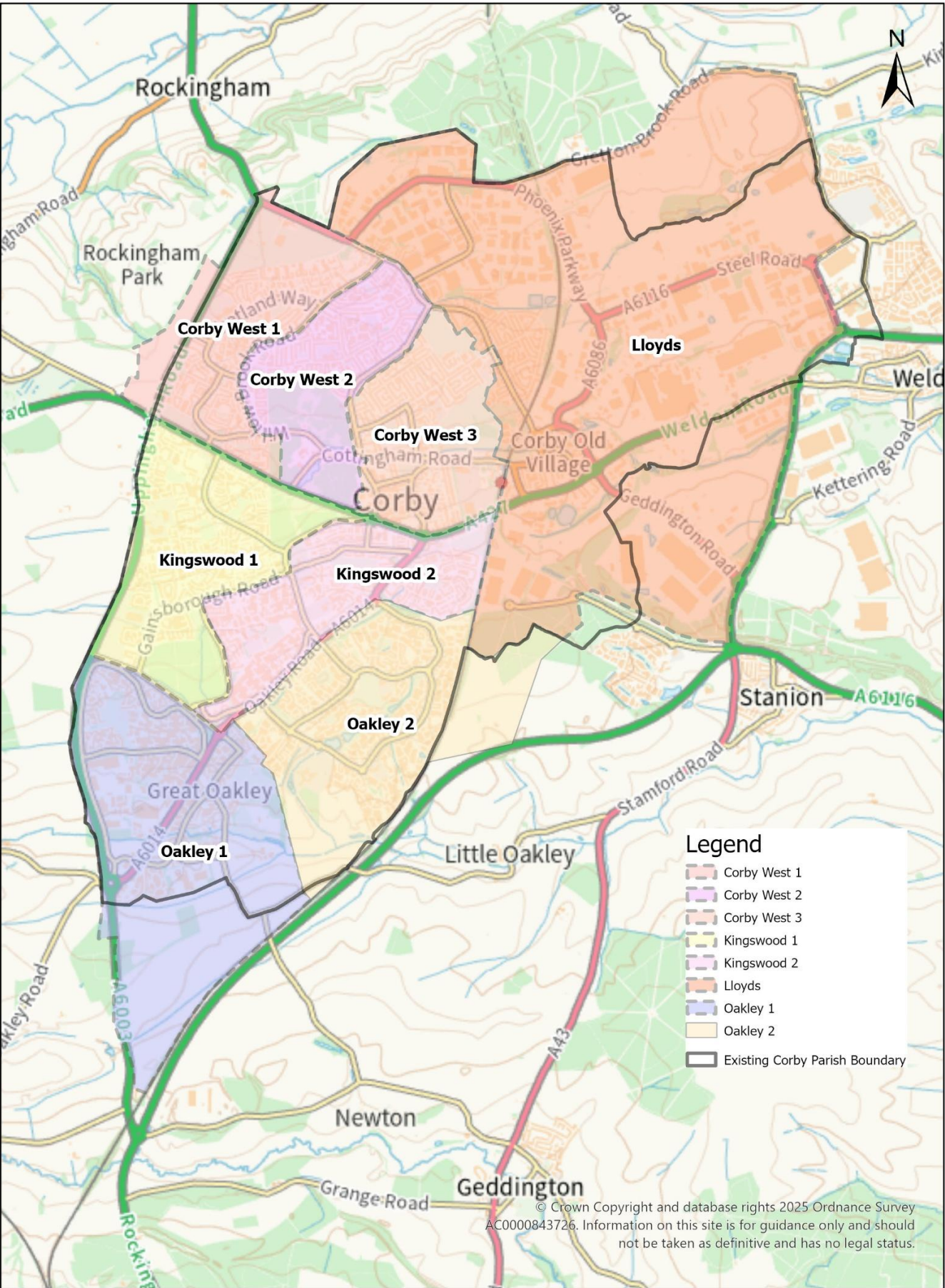

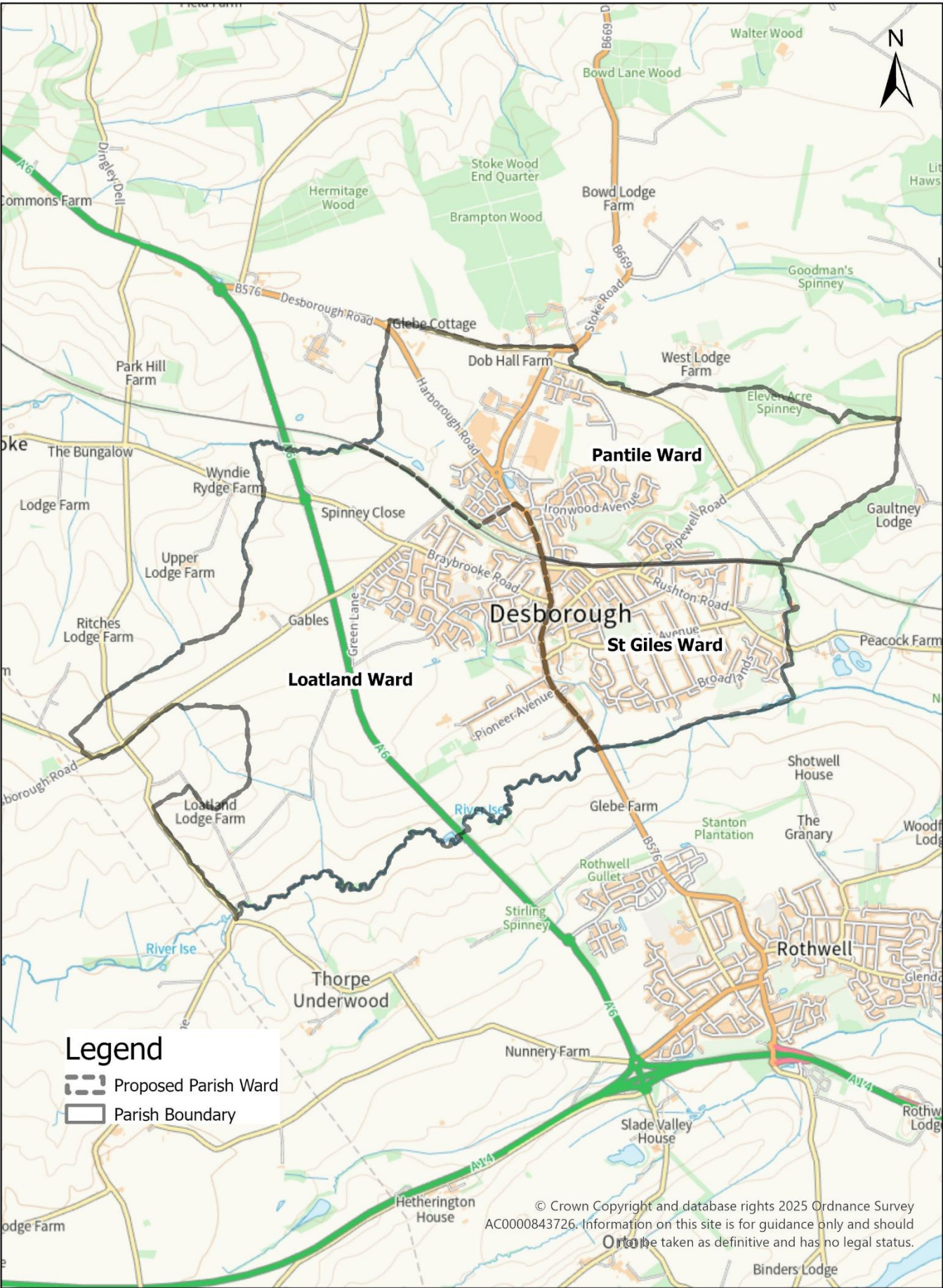

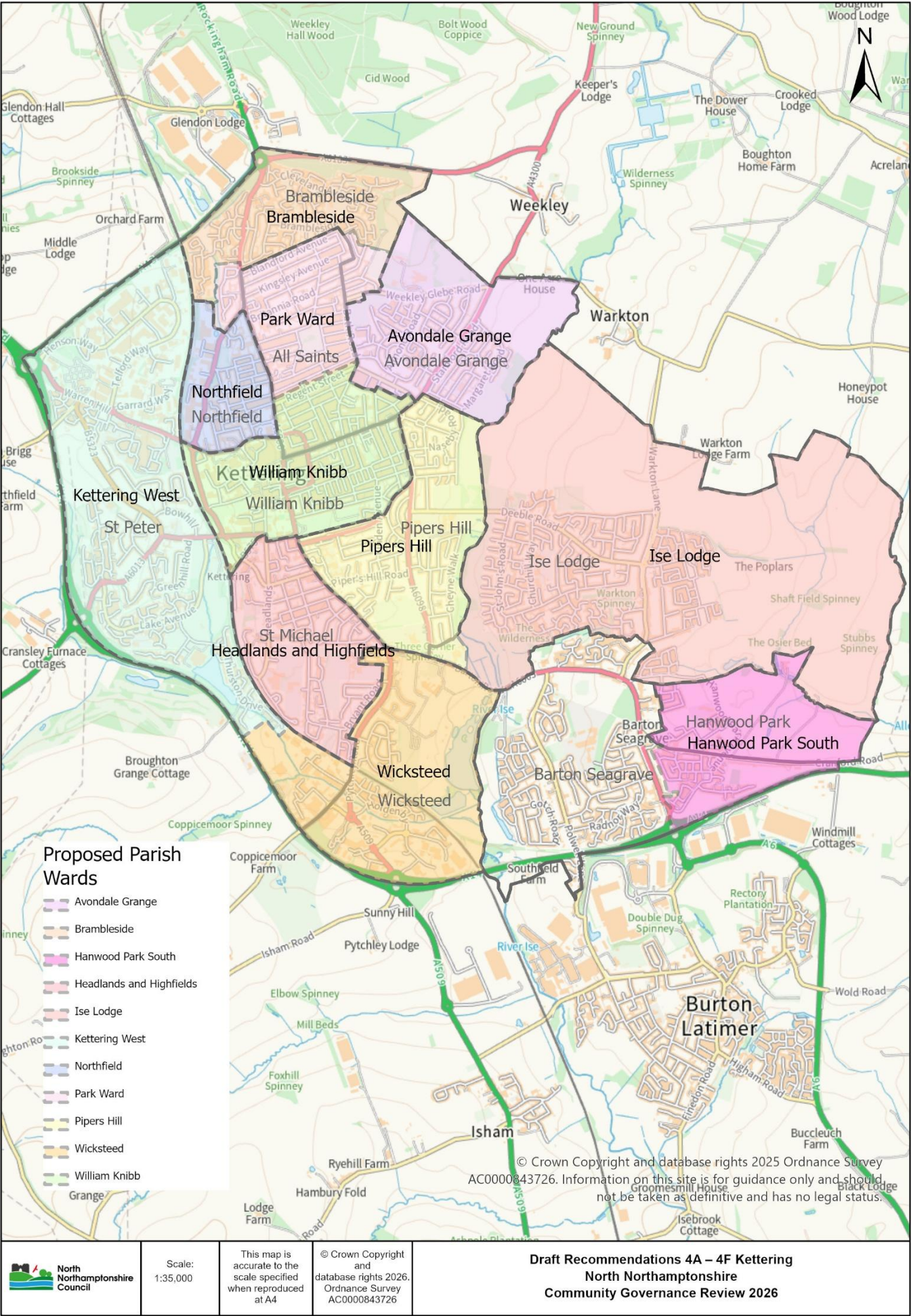

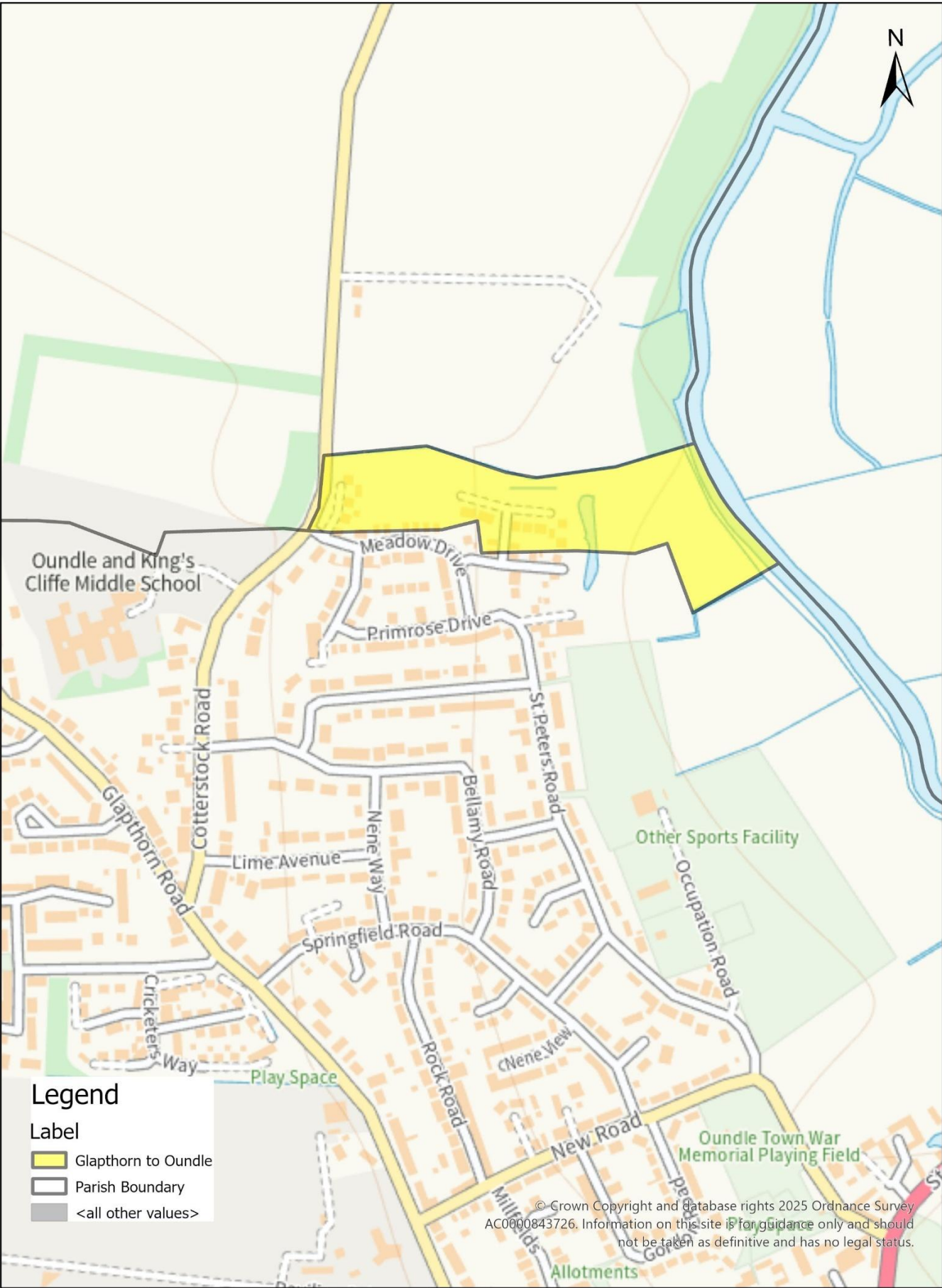

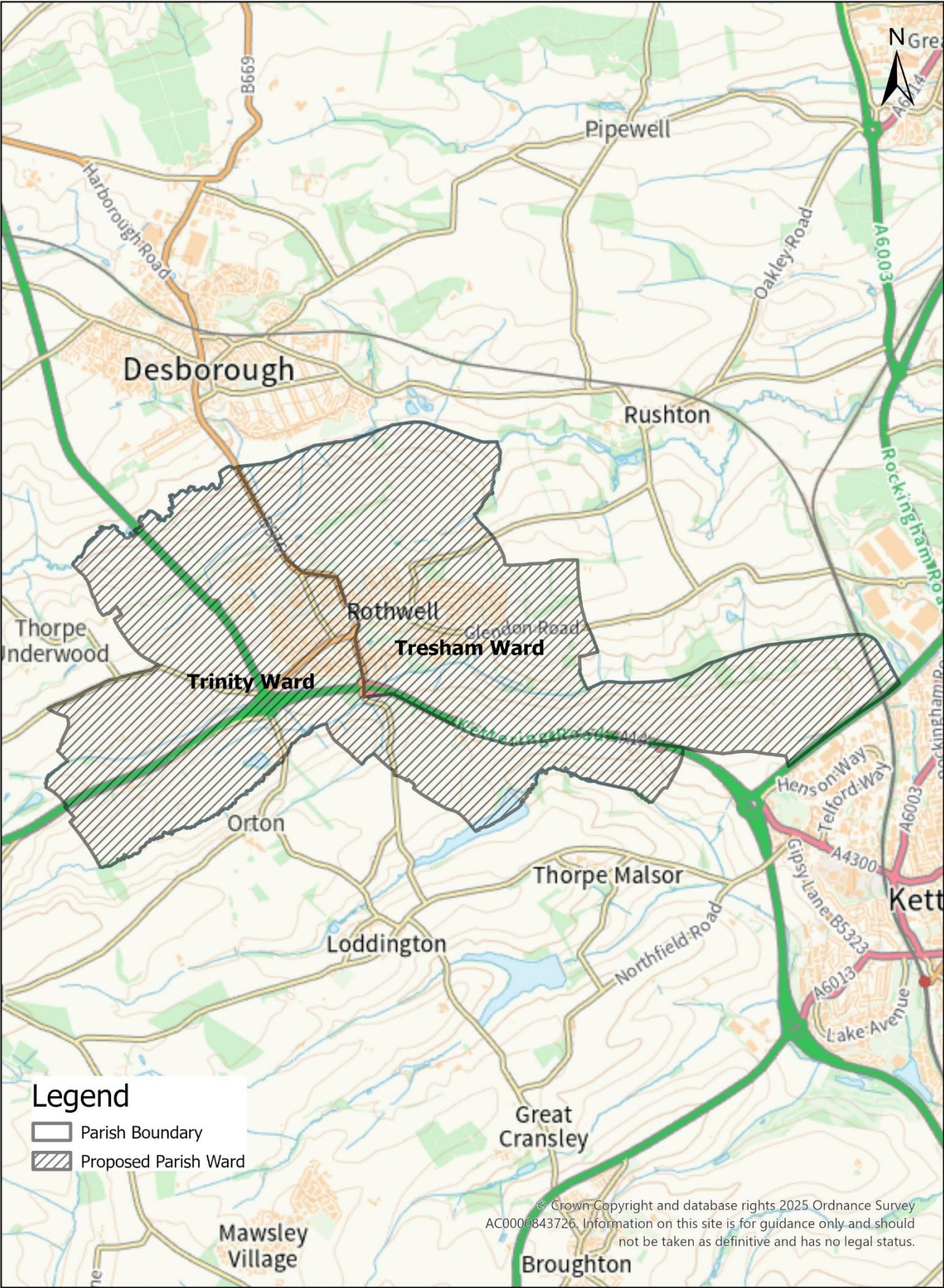


DRAFT RECOMMENDATIONS 4a – 4f KETTERING – that a revised warding pattern and ward names be taken forward for further consultation

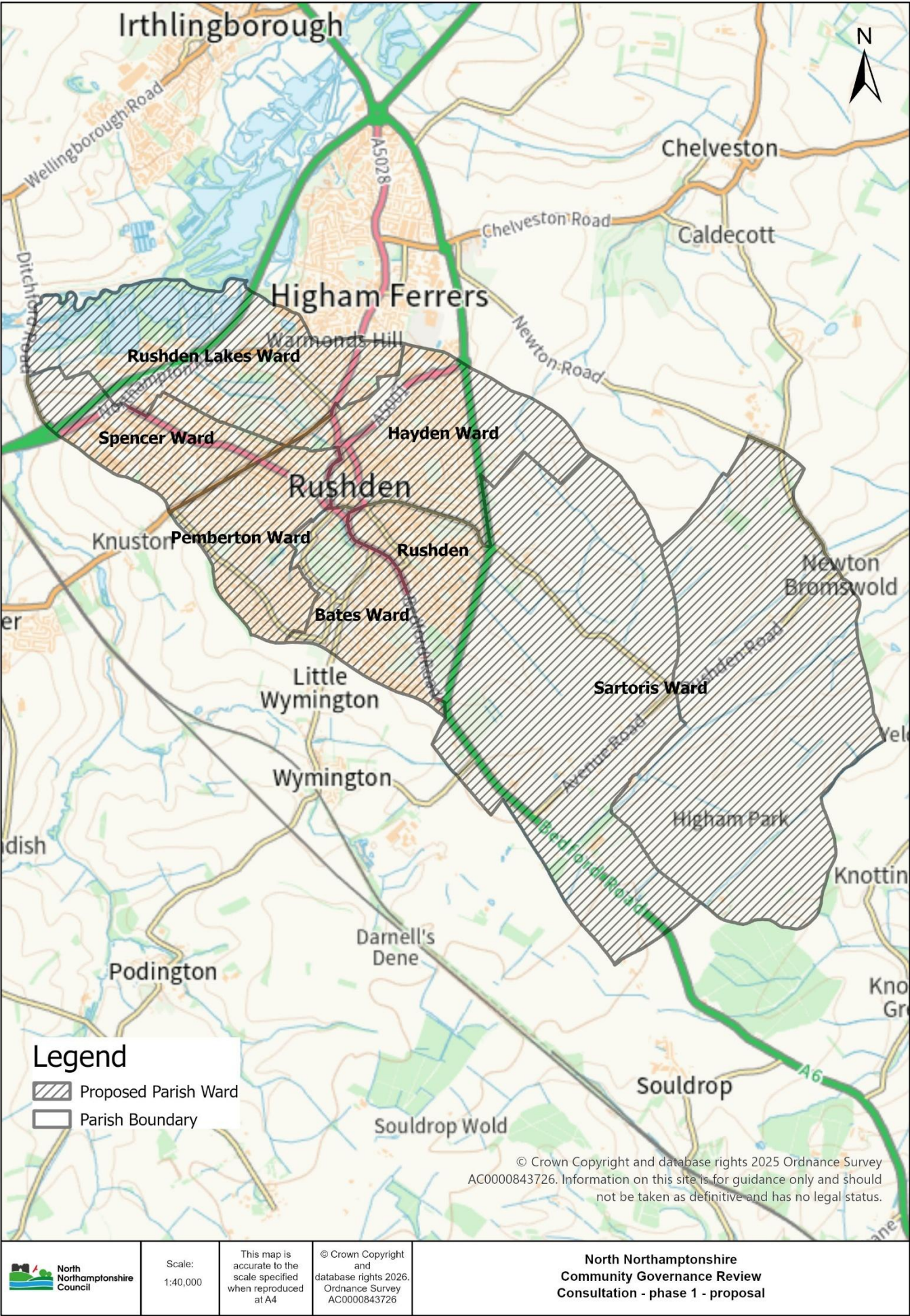

DRAFT RECOMMENDATION 9 WELDON – The area shown coloured yellow is currently within the parish of Deene & Deenethorpe.
