Twins and Multiple Births: A twin or children from a 'multiple birth' will be given a sibling link as soon as the first child is allocated a place. This is to avoid the situation where only one sibling of a multiple birth is successful in obtaining a place at the same school. The school will admit a twin (or other sibling from a multiple birth) even if this takes the number of admissions over the PAN, if to do otherwise would mean the siblings would be separated.  The wording has been amended to clarify that the Trust uses the Local Authority's services for the administration of admissions and the management of appeals and waiting lists.
Bishop Stopford School		Changes are being made to the oversubscription criteria:  Introduction of a 'local community' criterion to allow 4 local students to be allocated, ranked by distance from school (to become criterion 4).  Children of staff at the school will be prioritised in criteria 3, 4 and 5.  The Inter Faith Network no longer exists, so it has been removed from the admission arrangements and the SIF. It has been replaced by a reference to the census data, which identifies the core religions represented within UK society. This list of accepted religions is in appendix 1 and reflects the school's student population.
